



LIMITED WARRANTY

WARRANTY COVERAGE

Velocity Impact Products, LLC (Velocity), warrants to the original purchaser that any Velocity manufactured product shall be free of material defects in manufacturing for the applicable period specified below. This limited warranty applies to the products under normal use and service, subject to the conditions, exclusions and limitations described in this limited warranty, and for only so long as the original purchaser owns and occupies the property where the products are installed, subject to the limited transferability exception described in the paragraph below entitled "Transferability".

VELOCITY'S LIABILITY UNDER THIS LIMITED WARRANTY SHALL BE LIMITED TO THE REPAIR OR, AT VELOCITY'S DISCRETION, REPLACEMENT OF NONCONFORMING GOODS OR PARTS. VELOCITY SHALL NOT BE RESPONSIBLE FOR ANY COSTS INCURRED IN REPAIRING OR REPLACING THE PRODUCTS, OR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES THAT MAY ARISE OUT OF A CLAIM, INCLUDING WITHOUT LIMITATION, ANY DAMAGES OF ANY KIND.

REPLACEMENT PRODUCTS MAY NOT MATCH THE COLOR OF THE ORIGINAL PRODUCT, OR THE COLOR OF THE REMAINING WINDOWS AND DOORS IN THE HOME, AS COLOR MAY VARY DUE TO AGE, WEATHERING, DYE LOT DIFFERENCES OR OTHER FACTORS. VELOCITY WILL NOT BE RESPONSIBLE OR LIABLE FOR ANY SUCH COLOR DIFFERENCES ASSOCIATED WITH ANY REPLACEMENT PRODUCT AND WILL NOT BE REQUIRED TO HAVE THE REPLACEMENT PRODUCT "MATCH" THE COLOR OF THE ORIGINAL PRODUCT THAT IS BEING REPLACED, OR ANY OF THE WINDOWS OR DOORS THAT REMAIN IN THE HOME.

WARRANTY EXCLUSIONS

This limited warranty covers only those manufacturing and material defects as specified herein and does not apply to, cover or include defects or damages attributable to or caused by:

Improper installation, handling damage, improper storage, improper application or use, failure to adhere to Velocity's recommended cleaning and other product care and maintenance instructions, non-factory modifications, improper maintenance or cleaning, normal weathering, corrosive or otherwise abnormal environments, condensation (except as described in the section below entitled "Insulating Glass Unit"), accident, fire, flood, acts of God, water intrusion, including but not limited to water intrusion caused by wind-driven rain due to high wind events, vandalism, riot or civil disorder, building settlement, excessive building movement or structural failures of walls or foundations, localized heat which causes excessive temperature differentials over glass surface edges, aluminum components having direct contact with corrosive materials including but not limited to copper treated wood, such as Alkaline Copper Quaternary (ACQ), naturally occurring changes such as tarnish, corrosion, oxidation, or discoloration of hardware finishes or component parts, occurrences beyond Velocity's control.

This limited warranty shall be null and void if harmful solvents are used to clean the product; or if any portion of the product is painted or coated in any way at any time after the product leaves Velocity's factory; or if any other "aftermarket" products, such as window films, are applied to the Velocity product.

Caulking is used on some installations to seal the frames (or trim package) against water or air penetration. Caulking is not considered a part of the Velocity product and, therefore, is not covered under this warranty. Caulking is a maintenance responsibility of the owner.

THE ORIGINAL WARRANTY PERIOD SHALL NOT BE EXTENDED BY SUCH WARRANTY REPAIR OR REPLACEMENT. WARRANTY IS ONLY ENFORCABLE AND VALID IF PAYMENT HAD BEEN RECEIVED BY VELOCITY IMPACT PRODUCTS LLC, WITHIN THE PAYMENT TERMS SET FORTH WHEN ORIGINAL PRODUCT ORDER WAS PLACED

Velocity reserves the right to discontinue or change the design and specification of any product it manufactures. Should the component of the product originally installed not be available, Velocity shall have the right to substitute such part determined by Velocity to be of equal quality and performance.

THIS WARRANTY COVERS ONLY THOSE VELOCITY IMPACT PRODUCTS LISTED BELOW THAT ARE INSTALLED IN ORIGINAL PURCHASER OCCUPIED PROPERTY. THE WARRANTY PERIODS LISTED IN THE TABLE BELOW BEGIN ON THE DATE VELOCITY IMPACT PRODUCTS DELIVERS PRODUCT TO OUR CUSTOMER'S SPECIFIED LOCATION.

IMPORTANT COVERAGE INFORMATION:

FRAME

Aluminum components are warranted to be free of defects in materials and workmanship. It is typical for anodized products to have color variation and processing marks that occur during manufacturing. These are not considered defects or covered under the warranty. This limited warranty is null and void if any aluminum component has direct contact with a corrosive material including, but not limited to copper treated wood, such as Alkaline Copper Quaternary (ACQ).

PAINTED FINISH

This warranty is passed through from the manufacturer/extruder/painter and covers factory applied painted finishes for exposed aluminum surfaces against peeling, checking, cracking, chalking and change of color per applicable AAMA Specifications in force at the time of bidding. Painted finishes are warranted against corrosion for a period of ten (10) years and requires that care and maintenance requirements have been properly performed and documented in accordance with *Velocity Cleaning Procedures*. This limited warranty applies only to PVDF painted finishes and other warranty terms may apply when some custom finishes are applied. Velocity reserves the right to re-finish defective components in the field using air-dry products.

ANODIZED FINISH

This warranty is passed through from the manufacturer/extruder and covers factory applied anodized finishes or exposed aluminum surfaces against peeling, checking, cracking, chalking and change of color per applicable AAMA Specifications in force at the time of bidding. Anodized finishes are warranted against corrosion for a period of five (5) years and requires that care and maintenance requirements have been properly performed and documented in accordance with *Velocity Cleaning Procedures*. This limited warranty applies only to Class 1 clear Anodized finishes.

HARDWARE, SCREENS AND MOVING PARTS

Velocity warrants that mechanical operation of hardware, screen, and moving components will be free of defects in material and workmanship for the applicable warranty period described in the table above. This limited warranty excludes normal wear and tear and naturally occurring changes such as tarnish, corrosion caused by dissimilar metals (galvanic corrosion), oxidization or discoloration of hardware finishes or component parts, as well as any of the other warranty exclusions set forth herein, including the exclusions described above.

GLASS

Glass has prevalent characteristics such as distortion, bubbles, discolorations, blurs, debris, and scratches. These types of characteristics are expected, and are excluded from this limited warranty, as they are inherent qualities that meet or exceed standard specifications for flat glass ASTM C 1036, heat treated flat glass ASTM C 1048, and laminated architectural flat glass ASTM C 1172. Heat strengthened or tempered glass may have distortions as an inherent quality, and such distortions are excluded from this limited warranty. Glass with special coatings may require special cleaning. Glass breakage is not covered by this warranty. Visit www.velocityimpactproducts.com for additional care and maintenance information and glass policies. Failure to adhere to cleaning and any other recommended care and maintenance will void this limited warranty, as will any of the other exclusions set forth herein, including the exclusions described above.

LAMINATED GLASS UNIT

The glass is warranted to be free of defects that result in material obstruction of vision or delamination for the applicable time period specified in the table above.

INSULATING GLASS UNIT

The sealed glass component is warranted to be free of defects that result in material obstruction of vision or film formation caused by dust or moisture in the dead air space of a sealed unit, for the applicable period of time specified in the table above.

STRESS CRACKS

Stress cracks in glass panels are not considered defects in materials and/or workmanship, and are specifically excluded from Velocity's warranty

TRANSFERABILITY

This limited lifetime warranty is transferable to subsequent owner(s) as specified herein provided Velocity receives notice of transfer of title of the registered property within thirty (30) days after the date of ownership transfer, and provided such notice is accompanied by a copy of this Warranty and the order number for no additional fee. If this limited warranty has not already expired or been voided for other reasons, it will be extended to the subsequent owner for the remaining specified warranty period from the date Velocity originally transferred product to our customer, subject to the conditions, exclusions and limitations described elsewhere in this limited warranty.

SUPPLEMENTAL COMMERCIAL WARRANTY LANGUAGE: COMMERCIAL, INVESTMENT AND NON-OWNER-OCCUPIED RESIDENTIAL DWELLINGS

Velocity products installed in non-owner-occupied dwellings such as apartments and rental homes, or used for commercial purposes such as schools, churches, hospitals, government owned structures and office buildings are covered by this limited warranty only as set forth in the table below and are subject to all of the exclusions described in this limited warranty, including those exclusions listed on the first page of this limited warranty. THE WARRANTY PERIODS LISTED IN THE TABLE ABOVE BEGIN ON THE DATE VELOCITY TRANSFERS POSSESSION OF PRODUCT TO OUR CUSTOMER'S SPECIFIED LOCATION.

SUPPLEMENTAL EXPORT WARRANTY LANGUAGE: VELOCITY PRODUCTS INSTALLED OUTSIDE THE CONTINENTAL UNITED STATES

Velocity's liability under this limited warranty shall be limited to the replacement of nonconforming goods or parts subject to the provisions set forth in the table above. Velocity shall not be responsible for on-site inspections or warranty repairs and shall not be responsible for any labor or delivery costs associated with repairing or replacing products, or for any consequential damages.

CUSTOMERS RESPONSIBILITY

The life of your windows and doors increases with proper care and maintenance, and products require reasonable care and periodic cleaning. In salt-air environments, increased care and maintenance is required. As a warranty requirement, all Velocity products must be cleaned using tap water and a mild soap at least once every three months (four times annually) to remove surface contaminants. For properties located within 5 miles of the coast, the cleaning requirement is monthly. There must be trackable evidence of these actions by supporting documentation (maintenance log) such as invoices or work-orders from a professional cleaning company. Cleaning and maintenance are not the responsibility of Velocity and are not covered by this warranty. Visit www.velocityimpactproducts.com for additional care and maintenance information. The failure to follow recommended cleaning, care and maintenance requirements will void this limited warranty.

CLAIM PROCEDURE

Any claim for defect under this limited warranty must be submitted promptly after discovery to the independent dealer or distributor from whom the product was purchased and within the warranty period specified above. If you cannot locate the independent dealer or distributor from whom the product was purchased, you may contact Velocity for assistance at customerservice@velocityimpactproducts.com. To help us serve you better, all claims must include proof of purchase, product identification or order number, the address where the product is installed, and a description of the problem.

Some States do not allow the exclusion or limitation of incidental or consequential damages or the limitation of remedies for a breach of warranty, so the above limitations or exclusions may not apply to you. This warranty gives you specific legal rights, and you may also have other rights that vary from State to State.

*** NO DISTRIBUTOR, DEALER, OR REPRESENTATIVE OF VELOCITY HAS THE AUTHORITY TO CHANGE OR MODIFY THIS WARRANTY IN ANY RESPECT, EITHER ORALLY OR IN WRITING. EXCEPT AS EXPRESSLY PROVIDED IN THIS WARRANTY, THE PURCHASER'S EXCLUSIVE REMEDY IS LIMITED TO THE LEGAL REMEDIES DESCRIBED IN THE WARRANTY. IN NO EVENT WILL VELOCITY'S AGGREGATE LIABILITY UNDER THIS WARRANTY EXCEED THE ORIGINAL PURCHASER'S PAYMENT AMOUNT TO VELOCITY. VELOCITY WILL NOT BE LIABLE UNDER ANY LEGAL THEORY (INCLUDING BUT NOT LIMITED TO CONTRACT NEGLIGENCE, STRICT LIABILITY IN TORT OR WARRANTY OF ANY KIND) FOR ANY INCIDENTAL, CONSEQUENTIAL, SPECIAL OR PUNITIVE DAMAGES (INCLUDING BUT NOT LIMITED TO LOST PROFITS). VELOCITY MAKES NO WARRANTY, EXPRESS OR IMPLIED, INCLUDING NO WARRANTY OF MERCHANTABILITY, NO WARRANTY OF FITNESS FOR PARTICULAR PURPOSE, NO WARRANTY OF COMPLIANCE WITH BUILDING OR SAFETY CODES OR LAWS AND NO WARRANTY OF NON-INFRINGEMENT. THIS WARRANTY DOES NOT COVER DAMAGE TO THE PRODUCT, PROPERTY OR PERSON, WHEN THEY ARE CAUSED BY MOLD, FUNGUS OR ANY OTHER TOXIN NOT ATTRIBUTABLE TO A VELOCITY PRODUCT DEFECT. VELOCITY RESERVES THE RIGHT TO DEEM THE WARRANTY INVALID IF NOT ACCOMPANIED BY A BILL OF SALE OR DOCUMENTATION, WHICH CONSTITUTES A LEGAL AGREEMENT BETWEEN THE CLIENT AND VELOCITY. THIS WARRANTY IS PROVIDED IN LIEU OF ANY OTHER WARRANTY REQUIREMENTS OR OBLIGATIONS, INCLUDING THOSE OF PRODUCT SPECIFICATIONS OR GENERAL CONDITIONS OF CONTRACT DOCUMENTS AND VELOCITY DISCLAIMS ALL WARRANTIES NOT EXPRESSLY PROVIDED HEREIN. ***
